Primary Roles & Responsibilities

Board of Trustees: Meets monthly to provide broad parameters and financial management, transact church business, hire, receive resignation or recommend termination of Senior Pastor, maintain church policies and procedures, support the accomplishment of the Church mission, present annual budget for ratification by voting members, receive committee reports, authorize fund campaigns, fill Board vacancies, and maintain oversight of church property.

Leadership Selection Committee: Meets about 9 times a year to recruit potential Church Board and Committee members for recommendation to the Board of Trustees, inform potential candidates of their duties and responsibilities, obtain from each candidate a written consent to submit their name for ratification and prepare a list of candidates for vacant positions.

Missions Action Committee: Meets every other month to promote the work of Missions locally, nationally, and internationally, develop missions programming, work with staff to maintain an education and awareness of Missions opportunities within the congregation, administer funds allocated to missions, prepare an annual budget to be presented to the Board of Trustees for approval, and working with church Finance Office to facilitate the appropriate disbursement of allocated funds.

First Church of God Foundation Board: Meets four times a year to review applications and award scholarships to members of Vancouver Church or graduates of King's Way Christian School, direct funds to benefit the ministries of the Vancouver First Church of God through scholarships, Christian education, missions, buildings and facilities, and general fund expenditures.

Eligibility

We request that each person who fills out a questionnaire affirm the following:

- I understand that I may or may not be called to consider serving as a result of filling out a questionnaire
- In the event I am called upon, I agree to cooperate with additional information gathering and to prayerfully consider serving at Vancouver Church
- I have personally accepted Jesus Christ as my Lord and Savior
- I am in joyful agreement with the Vancouver Church Mission Statement: We seek to become an authentic biblical community effectively reaching out to our churchless neighbors with empathy, grace and truth so they can experience a whole new life with Jesus and like Jesus more every day.
- I am very supportive of the current Vancouver Church leadership, staff and Board of Trustees.
- I am 18 years of age or older.
- I have attended Vancouver Church for at least 6 months.
- I regularly support Vancouver Church financially as an act of worship.
